Re: Connie Vargovich and the Favors You Provide Her

Judge Madden:

This letter concerns your ongoing involvement with Connie Vargovich, specifically in regards to her most recent drunk driving charge which was improperly charged by DA Lipske as a first offense, which you dismissed. First of all, it was not her first offense. She was previously convicted of drunk driving in Iron County in 1996 after she entered a plea of guilty, at which time you extended her the personal favor of not putting her in jail and not assessing any fines or costs. She had pleaded guilty, then simply walked away.

But you are not fooling anyone, as our entire community knows that it is your corruption that causes my ongoing imprisonment, and your dismissal of Connie's recent charge is just another illicit act in an established ongoing pattern of your protecting her and providing her favors while denying me justice.

Angry that I have simply published the truth and am publicly exposing this gross and blatant injustice, you will surely plot and scheme to again get revenge against me and you will also continue denying justice for me. Your moral compass is badly broken and you clearly are unfit for any judicial office. You are indeed a MONSTER.
