

NOTE TO WEBSITE VISITORS FROM DON:

I recently read an article in the Ironwood Globe paper saying Iron County released three men from jail accused of sexual assault by Tamra Coyne. DA Lipske had them thrown in jail, filed a criminal complaint in the court, but later asked Judge Madden to dismiss the charges due to inconsistency in Coyne's statements. Madden dismissed the complaint and the three were released. DA Lipske was quoted as saying he may bring criminal charges against Coyne if he found any false information in her statements. DA Lipske has now filed a criminal complaint against Coyne for allegedly falsely accusing these men. The basis for his complaint was that Tamra made "inconsistent statements" and police were 'unable to place them in the area of the assault', though Coyne did identify them. Very Interesting! DA Lipske is prosecuting Coyne because he claims the evidence shows she did make false accusations. **BUT WHAT ABOUT CONNIE VARGOVICH?**

Everyone visiting our websites knows the evidence against Connie Vargovich is far greater in quantity and strength than the evidence against Coyne is, yet Coyne is the one being prosecuted, not Connie! If fact, Connie is not even being questioned. The obvious explanation is that Coyne was not the one sexually or socially involved with Judge Madden, and Connie Vargovich was. There can be no other reason.

I have little sympathy for false accusers, but I don't know whether Coyne is guilty. But I do know Connie is guilty, and so do DA Lipske and Judge Madden. I therefore fear that Lipske and Madden are looking to railroad Coyne for their own purpose of trying to make themselves 'look good' because they know our entire community is outraged at their intentional perversion of justice in my case and they know the evidence proves me falsely accused and wrongfully convicted. They do nothing to help me and are protecting my false accuser, Connie, from prosecution.

My entire community is on my side because uncontested evidence speaks for itself and clearly proves I am purposely being denied justice. DA Lipske and Judge Madden have been to these websites and they see the same evidence you do. I also sent it to their offices. Hard evidence proves everything I say to be absolutely true and they can't, and don't, deny Connie has falsely accused me, and yet she is not the one being prosecuted.

By prosecuting Ms. Coyne, Iron County is proving that Connie is escaping punishment only because she and Judge Madden were sexually involved. And DA Lipske and Judge Madden will never 'look good' until I'm home and Connie is in jail. Everyone should be asking a simple question: Why is Tamra being prosecuted on scant evidence while Connie Vargovich is not being prosecuted or even questioned, where the evidence against Connie (including Connie's own confession of my innocence) is FAR stronger than the evidence against Tamra Coyne? Connie is being protected; Tamra likely is the scapegoat.
