

## A Note from Don to All Website Visitors and Supporters

Hi Everyone,

I really want to thank you all for taking an interest in my case and especially for your concern, support, comments and prayers. I am very blessed to have so many good people speaking up for me. Thank you so much. My life is a bit easier knowing that my community knows I am falsely accused and intentionally wrongfully convicted by some corrupt and evil individuals. You know who the real criminals are in this case.

I went before the Parole Board for the first time on May 19, 2008, but parole was denied. They didn't like the fact that I refuse to "confess" to something I did not do so told me they would not consider me again until the year 2013. The board acknowledged my community support, acknowledged your comments and petition for my release, but said:

"To release you now would pose an unreasonable risk to the community and would seriously depreciate the seriousness of the crime."

That's very interesting, since my own community does not see me as any risk, wants me home, and no crime was committed by me. The only person who is opposing my parole (can you guess?) is CONNIE VARGOVICH. Ever the **actor** and **liar**, Connie claims she is "still traumatized" so does not want me released. Traumatized by WHAT?? She is the one who has committed crime here, and she has personally CONFESSED my innocence to her friends and others. Connie just can't stop lying. I'm the one "still traumatized."

Obviously, Connie opposed parole as an act of **RETALIATION** for websites that expose her for who and what she really is, especially after reviewing all the evidence on the websites and considering the comments made by her closest friends. As we all know, leopards cannot change their spots and this is why Connie continues to lie. She confesses my innocence to friends, but changes her story whenever she has opportunity to cause me and my family more suffering. Connie is well known by the entire community, and especially those who know her best, to be a pathological liar and very evil hearted person.

The list of evidence proving Connie falsely accused me is extensive, her sister is an eyewitness to the fact I am falsely accused, and Connie herself confesses my innocence to friends. Even DA Lipske himself admits she falsely accuses people and that she falsely accused me again in 2005. And she opposed my parole? It is obviously **RETALIATION** for showing you the truth and proving everything that I say with hard evidence.

Why won't Connie tell the truth and DA Lipske just admit that mistakes have been made? Because truth NEVER seems to be an option they choose. Rather, they choose to continue in a charade, lies, deception, and crime. Judge Madden and DA Lipske both know the truth is out and that you all support me and that is why they did NOT oppose my parole. But they should be doing everything possible to get me out of here ASAP.

It is really amazing how much deception and lies are now exposed in this case, with more to come. I challenge them to disprove any statement or evidence we present, but they know the proof is solid and know they would only look worse if they tried. They know everyone can see that this is a wrongful conviction, so why don't they help me? I pose such questions to them, but they don't answer. My attorney said they have not released me because they fear lawsuits. I think it is more likely to be mental defects; I know Connie is mentally ill, and considering all the lies DA Lipske has been caught in during his career and in this case, prior disbarment for lying, etc., he acts just like Connie's twin.

So what kind of people are these who can't stop lying, feel no remorse for wrongful and hurtful acts, disregard pain they inflict on others, seem unable to act within society's expectations and don't give a damn about what you or I say about anything? Well, I researched mental health books and found a Personality Diagnostic Checklist in the *World Health Organization's Manual of Mental Disorders*, which provides the following criteria for the diagnosis of a psychopath:

- Callous unconcern for the feelings of others;
- Inability to feel guilt for their wrongful actions;
- Deceitfulness: repeated lying and conning others;
- Failure to conform to social norms with respect to lawful behavior.

I am not a psychiatrist so am not qualified to diagnose psychiatric defects, but maybe they should not try so hard to fit so perfectly into this Diagnostic Checklist. A teacher at the University of Wisconsin, Dr. Kevin Barrett, said: "The only conspiracy that matters is that of the psychopaths against the rest of us." How true.

In most cases, a judge and DA will always oppose an inmate's parole. It is unheard of for both a judge and DA to not oppose parole. Not opposing my parole was a step in the right direction for Judge Madden and DA Lipske, but an unacceptably weak step. It is a silent admission that they know I am entitled to relief but they know I won't be paroled unless I "confess," and they know I can't and won't do that so will never be paroled. They know they should be working very hard to get me home ASAP. Anything less is insufficient.

Today is my 11<sup>th</sup> birthday spent in prison; I am 48. I miss my family terribly and this aching in my heart never goes away, and won't go away until I am home where I belong. I hope you appreciate and love your family; please tell them you love them, spend lots of time with them, and be happy. Because if something like this should ever happen to you or your loved ones (God forbid), you will miss them just as much as I miss mine.

I need you to speak up for me, so please don't be afraid to speak up and make comments. The more who do, the more we will be heard. Every little bit helps, so please do anything you can. Your interest, comments, and any other help is truly appreciated. I will keep you posted if anything new happens. Until then, please comment, write letters, and have your friends and family visit these websites. Thank you all for caring about me and my family.
