

MESSAGE FROM DON MILLER TO ALL SUPPORTERS

Hello Everyone!

Well, the race for Iron County DA had raised my hopes that Martin Lipske would lose the election and be replaced by a moral and ethical attorney having a keen sense of duty and a conscience. But Mr. Lipske won the election. This is most unfortunate for me because it was brought to my attention that the two attorneys running against Mr. Lipske are not happy with the way he conducts business. One of the attorneys made it clear that they would reopen my case as one of their first official acts if elected. The other attorney made it clear that all that is written about DA Lipske's mishandling of my case is very familiar to that attorney, who has had the same experiences when dealing with Mr. Lipske and expressed great concern about Mr. Lipske abusing his powers, overcharging people, failing to investigate, and showing "casual disregard for facts." Unfortunately, Mr. Lipske will remain the Iron County DA for now, unless removed from office.

Had anyone other than DA Lipske won the election, it is clear that I would have obtained the long overdue relief that I am entitled to and would be on my way home in no time at all, and Mr. Lipske winning the election was like a kick in the stomach.

All I can hope for is that my supporters will renew their desire to help me and speak up on my behalf. I am still waiting for my attorney to do something. There are so many issues to be raised that would get me a new trial, and we have new evidence and new witnesses as well. So what my attorney is waiting for, I can't even guess. On October 19th, I will have been locked up for 11-years for non-existent crime. How Connie Vargovich, DA Lipske, and Judge Madden can face themselves in the mirror every day is way beyond me because they all know there was no 'rape', and no other crimes, which Connie herself has even admitted. These are some very evil and disturbed people, no doubt. I need your help now more than ever. I continue investigations and am obtaining

new and useful information on a regular basis, and just recently from two local area police officers who have finally decided that they won't stand by and watch Judge Madden, DA Lipske, Sheriff Bruneau, and Connie get away with destroying innocent people and their families. So we now have two local police officers on our side and they will be helping stamp out Iron County corruption. But what about all the other police officers? Are there only two honest cops in all of Iron and Gogebic counties that know something about this case and the people involved? If there are other honest police officers out there having knowledge to share, we would like to hear from you as well.

Ms. Nadya Kangas worked as a deputy clerk in the Iron County Court-house for 26-years and recently retired. She wrote a letter to the Editor of the Ironwood Daily Globe Newspaper which was published Sept. 4, 2008. In her letter to the public, she made it clear that Mr. Lipske, the current Iron County DA, has personal biases and a personal agenda. More and more people are speaking out and we now have so many supporters, and even Connie's friends have come over to our side. Why would Connie's friends bail out on Connie? Because they don't like the fact that Connie is so cold and cruel as to falsely accuse someone and then do nothing to help correct the situation. No, not everyone is as sick as Connie.
